The Daniels College of Business held its 2013 Daniels Honors Convocation Breakfast on Friday, May 17th at The Cable Center. The convocation event is held each year to honor the outstanding service and dedication of Daniels staff, professors, lecturers and students. We were excited to celebrate the accomplishments of the School of Accountancy.

- Dr. Richard Leaman received the Daniels Outstanding Service Award. Rick serves his profession,

department, college and the University. He serves on the University Senate and has chaired the Senate Finance Committee since September 2007. Rick has served on a variety of searches. Most recently, he served on the search committee for an assistant professor position in BELS. Rick serves his profession through the Colorado Society of CPAs where he serves on the Accountancy Regulation Committee. Rick chairs the Corporate Tax Policy Subcommittee of the American Taxation Association where he helps develop tax policy proposals. On a University level, Rick has helped shape the university by interviewing prospective students through the Ammi Hyde interviews. Rick is a humble supporter of the School of Accountancy, Daniels, DU and the CPA profession in many behind-the-scenes ways. We are excited that he was honored with this award.

- David "Buff" Honodel received the Adjunct Faculty Excellence in Teaching Award. He was nominated by 2 professors and 18 students. In speaking of Buff, Assistant Professor Philipp Schaberl said, "Despite having taught at DU for more than 20 years, Buff is constantly refining his craft. He makes an effort to speak with potential employers and learn what they are looking for in Daniels graduates. Hence, Buff ensures that his students not only acquire a solid understanding of the material covered in class, but that they also demonstrate character, professionalism and integrity."

- Lecturer **Kathleen "KED" Davisson** received the Inclusive Excellence Faculty Award. KED was nominated for this award primarily because of her efforts in serving as the program lead for the Accounting Scholars Development Program (ASDP). The ASDP is an outreach program for community college students in the Black, Hispanic and Native American communities. The program will have its 3rd go around at the beginning of July as we welcome 30-40 students to the DU campus for a 5-day, 4 night residency aimed at underrepresented minority students who are interested in pursuing career opportunities in accounting. As the program director, KED increases the inclusiveness of the program by recruiting counselors and training them. KED lives in the dorms with the ASDP participants and accompanies them to all activities. KED keeps in touch with the participants and encourages them to apply for transfer to DU. Two of the 2012 participants transferred to DU after the ASDP program at the encouragement of KED. This honor was well deserved.

- Undergraduate Student, **Katey Webber**, was nominated and awarded with the Daniels Award for Excellence. Katey was nominated by Dr. Sharon Lassar to receive the award as she has shown "the foundational interest, superior academic abilities, and the leadership skills to succeed as an accounting professional and to use her capabilities in future years to benefit the accounting community." Katey is one of many of our graduates who will make a difference in the accounting profession. She has dedicated herself to collaboration, time management, inclusive interpersonal relationships and community service.

SoA Welcomes New Executive in Residence

The School of Accountancy will welcome Robert Troccoli as an Executive in Residence (EIR) for the 2013-14 academic year. Mark Wehrle and Joe Bagan haven served as EIRs since the beginning of their year. The Daniels College of Business is dedicated to educating ethical business leaders, advancing the theory and practice of business and making a positive global impact. The EIR program furthers these goals by inviting executives at the forefront of business to share their experience and insights with our students, faculty and the College leadership. As Robert joins the SoA team, some of his activities will include one-on-one student career advising, guest lecturing and participation in industry panels, case writing and/or competition judging, advising student organizations in his area of expertise and participation in advisory boards for College leadership.

Robert worked for KPMG from 1971-2010 serving in many roles including Global Lead Partner and Lead U.S.



Partner for their Sovereign Wealth Funds. He also served as the Lead Audit Partner for several large Mutual Funds and Investment Advisors including OppenheimerFunds, Inc. and the Davis and Selected Funds.

We look forward to working closely with Mr. Troccoli during the 2013/14 academic year.

School of Accountancy Offers Valuation and Modeling Course This summer Dr. Keith Sellers and Mark Wehrle will team up to offer a new MAcc elective course: Valuation and Modeling. The course is designed to give MAcc students the knowledge and skills necessary to evaluate a wide variety of financial instruments including fixed income securities, equities and a wide variety of derivatives. Students will also strengthen their modeling skills by constructing binomial lattice models, calculate and compare company betas and cost of capital, and design hedging strategies. Financial reporting and auditing issues related to many of these topics will also be explored.

Mark was the lead audit partner for Deloitte & Touche LLP from 1987 - 2010 for regulated investment companies as well as public and private entities, with a focus on financial services. He developed and executed financial statement and internal control (SOX 404) audits included in 1940 Act and 1934 Act annual reports; supported RIC new-fund launches and corporate IPOs; solved complex accounting and financial reporting issues; reported audit results to audit committees and management and advised them on accounting and internal control issues and solutions.

Beta Alpha Psi President and dual BAcc/MAcc accounting student, Danika Tibbetts was recently nominated and selected for the very prestigious FASB Postgraduate Technical Assistant Program.

Both the Financial Accounting Standards Board and the Governmental Accounting Standards Board sponsor a postgraduate technical assistant program twice a year (programs commence in summer and winter) for individuals who are planning a career with an emphasis in accounting. Each program is a one-year term, during which the individual becomes highly involved with the accounting standards-setting process and

comes to have an in-depth

understanding of the roles played by preparers, auditors, and users of financial information.

Danika's responsibilities will include being assigned to major agenda projects or to short-term practice and implementation issues, depending on the need for staff assistance. She will be involved in all phases of their assigned projects, including analyzing written submissions received on documents issued for public comment, reviewing and analyzing published research, preparing memorandums on technical issues for



Board members' information, drafting due process documents, and evaluating accounting proposals of other organizations. Additionally, Ms. Tibbetts will attend and occasionally participate in public Board, task force, and other meetings pertinent to their projects.

We are thrilled for Danika and look forward to her success in the future. While she waits for her PTA Program to start in January, Danika will be working for the School of Accountancy. In particular, she will be coordinating a team of 5 professionals to help teach ACTG 4575 in the fall. She and alumna, Katrina Schuler,

are also assisting professors Sellers and Wehrle with ACTG 4700 this summer.
