### **THERE ARE TWO POSSIBLE ADMISSION PATHWAYS INTO DANIELS AS AN ENROLLED DU STUDENT:**

#### **FAST TRACK ADMISSION**

Upon successful completion of the following:

- Two quarters as a full-time student (minimum 12 GPA-bearing credit hours per quarter)
- Completion of MATH 1200 or 1951 (Calculus for Business or Calculus I)
- 3.5+ cumulative GPA

#### **PRE-BUSINESS PATHWAY**

Upon successful completion of the following:

- Prerequisites listed on the next page (with a Pass Plus or letter grade of C- or higher)
- Completion of the Microsoft Office Suite Certificate (Excel, PowerPoint, Word)
- 2.5+ cumulative GPA (3.0 is preferred)

## SUBMITTING YOUR DANIELS PRE-BUSINESS FORM

You will need to wait for final grades to be released on required classes before completing the form. The form is open throughout the year and submissions will be reviewed weekly on Tuesdays and Fridays. If your form is approved, a change of major form will be submitted to the Registrar, and you will receive notification to your DU email that your major(s) have been changed within five business days.
